Minutes for 2/5/2020 SAC Board meeting

The Meeting was called to order by Conner Wenzel at 6:08pm

Silas gave a staff report:

Salesforce has been an improvement in the office's efficiency and professionalism. Salesforce will be the vehicle to bring volunteer sign ups to the center website. The office getting is being upgraded and there are more accessible workspaces. The interns are resourceful and helpful. 600 people altogether are coming to the center's 13 support groups. Becky and Rocky have been assets and both have done much front desk work.

Celeste provided directors report covering:

Salesforce: Entered *474 contacts* in Salesforce. Form to track training is complete and being used. Member form to track people is completed and being used o Volunteer/Intern form is done and we are working on all sign ups going through Salesforce. FAQ section is ready to put in a searchable section where staff/interns/volunteers can find answers to their questions. Task/Phone messages section is being used. Grant opportunities section is being used. Participation page is ready and somewhat being used. Feedback form is complete but no entries yet. Transportation Assistance form is done and we are now logging bus passes and gas cards through Salesforce. Still need to develop: Forms such as art, entertainment submissions. Invoices for training.

Becky is working front desk M-TR noon-6 through June 2020.

Saturday, Jan 11 Support Group Facilitator training was successful and another is being planned.

Working with Shannon at Passages who will soon be starting a support group for the older LGBT*Q+ demographic.

5 interns are up and running

10 computers donated and 4 new work stations have been set up Event budget has been created and will be emailed out to the board.
